## "JACK DANIEL'S USA BBQ LOVER'S DREAM TRIP" PROMOTION

## **TERMS AND CONDITIONS**

- 1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Entry is only open to Australian residents (excluding NT) aged 21 years or over.
- 3. Employees (and their immediate families) of the Promoter, Participating Stores (defined below) and agencies associated with this promotion are ineligible to enter.
